KNOW ALL MEN BY THESE PRESENTS, That the undersigned, hereinafter called the assignor, for the consideration hereinafter stated, has sold and assigned and hereby does grant, bargain, sell, assign and set over unto ROBERT JONES AND DONA JONES, HUSBAND AND WIFE

hereinafter called the assignee, and to assignee's heirs, successors and assigns, all of the vendee's right, title and interest in and to that certain contract for the sale of real estate dated June 15, 1994, between GENE R. BYRNES, BILLIE SCHRIEBER, JAMES RAY BYRNES TRUST ETAL as seller and FRANK J. 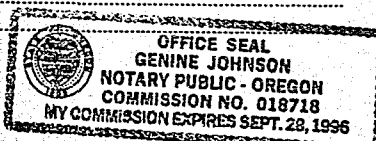
