KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated May 25, 19 78, executed and delivered by JOHN B. BROWN & MONICA L. 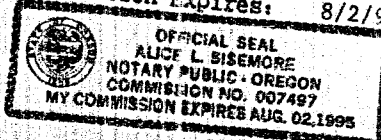
