KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated August 24, 19 90, executed and delivered by IRA W. BEARD & MARGIE M. 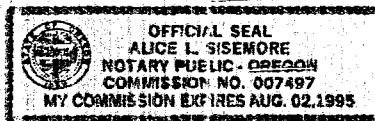
