ORDER

1. NATURE OF THE REQUEST:

The applicant wishes to establish a residence as a use NOT in conjunction with farm use on 1.95 acres east of the Modoc Point Rd., 300' north of Lake Forest Dr., Agency Lake

This request was heard by the Hairings Officer JULY 8, 1994 pursuant to Ordinances 44 and 45. The request was reviewed for conformity with Land Development Code Sections 54.060 and O.R.S. 215,243.

2. NAMES OF THOSE WHO PARTICIPATED.

The Hearings Officer in review of this application was MICHAEL L. BRANT. The applicant appeared and offered testimony in support of the application. The Planning Department was represented by Kin Lundahl, Senior Planner. The recording secretary was Karen Burg.

3. LOCATION:

The property under consideration is located in a portion of the NW 1/4 NW 1/4 Sec. 18, T 35S R IE, T.A. 3507-13-204, Parcel 3, LP 17-38.

4. RELEVANT FACTS:

The property is within the Agricultural plan designation and has an implementing zone of EFU CG. The property is located east of the Modoc Point Rd., 300' north of Lake Forest Dr., Oregon Shores, Agency Lake. The property is 1.95 acres in size and is NOT under farm tax deferral. The Land Use Capability Classification of the property is Class IV LOBERT (486). The properties adjacent to this property in all compass directions are found devoted to low intensity pural/agricultural use. The zoning in the area is R-1, having been the subject of recent applications (LUP/ZC 12 & 13-94 approved by the BOCC 6-28-54. Surrounding residential use includes 12 homes within a one-quarter mile radhis.

The property is within a structural fire protection district (C/AL RFD) and the proposed dwelling will be within a response time of 15 minutes.

5. FINDINGS:

All evidence submittee as the staff report, exhibits b-d, and offered testimony show that the approval criteria as set out in Code section 54.060 and 0.R.S. 215.243 have been satisfier. The Hearings Officer finds this applica-

tion;

1. Is compatible with farm use is caused

The project site will be legally and ownership divided from adjacent properties. The project site is found not to be devoted to commercial agricultural use and the conversion to such would be impractical because of the parcel

size and surrounding land uses

The Hearings Officer finds that the use of the remnant parcel as a homesite compatible with potential agricultural use because the applicant has demonstrated that no conflict will result from the conversion of an existing 1.95-

acre property to residential us

2. Does not inteffere seriously with accepted farming practices on adjacent lands devoted to farm use becauses

The properties to the north it all compass directions are found to be engaged in rural use. The property in question s found to be of little resource value due to its location, topot raphy, soils limitations and size which is far below the minimum lot size (80 acres) thought to represent a viable agricultural property (HB 3661

The permit holder has volunteers i as a condition of this approval to file a restrictive covenant which will prohibit the permit holder and successors in interest from filing complaint concerning reasonable farming practices on adjacent lands.

3. Does not alter the stability of the overall land use pattern of the area because:

The overall land use of the area is long established to rural lifestyle and will not be compromised by the conversion of an existing remnant parcel to a non-farm use. The land use pattern of the area will not be modified and will be perpetuated by this permit.

4. Is situated up in generally unsuitable land for the production of farm, crops and livestock, considering the terrain, adverse soil or land conditions, drainage and flooding, verification, location, and size of the tract because:

The existing parcel is 1.95 acres in size. The Hearings Officer finds this parcel size unsuitable for commercial agricultural use due to its size, poor soils, micro-climate and topography. The impact of removing this marginal value land from the County farmland base is found to be insignificant. 5. Complies with other conditions tell necessary, because;

The property is within a structural fire protection district. The potential exists that an existing residential use could cause a structural fire to spread to adjacent ands. Accordingly, the Hearings Officer finds the requirements set out in L.D.C. in concert with the structural fire protection provided by C/AL RFD, will protect the resource land base that could result from any possible fire mazard posed by the non-farm residence.

6. ORDER:

Therefore, it is ordered the request of WOHRHAN for CUP 68-94 is approved subject to the following conditions:

1. The applicant shall file a restrictive covenant with the County Clerk prohibiting the permit holder and their successors in interest from filing complaint concerning accepted resource management practices that may occur on nearby lands.

2. The Conditional Use Permit shall not be final nor shall a building permit for a non-farm dwalling be issued under this order until the applicant provides the Planning Department with evidence that the lot or parcel upon which the dwelling is proposed to be located has been disqualified for valuation at true cash value for firm use and that any additional tax penalty imposed by the County Assessor has been faid.

3. This permit will expire in two years unless the approved residence is established or a requist for an extension of time is filed with the Flanning Department.
