In construing this instrument and whenever its context so requires, the singular includes the plural.

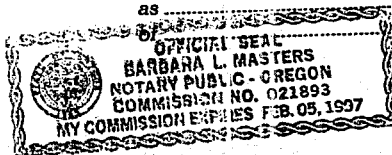

DESCRIPTION OF PROPERTY
