The true and actual consideration for the conveyance stated in dollars is the sum of \$20,000.00

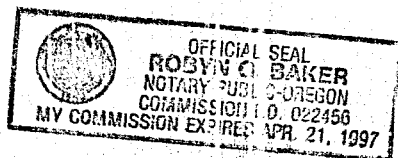

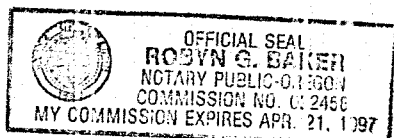

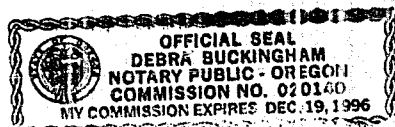
