hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by BENNY J. GARCIA and SALLY ANN GARCIA, husband and wife, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, the certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

The South 75 feet of the North 475 feet of Lots 1 and 2, Block 5, SECOND ADDITION TO ALTAMONT ACRES, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon, EXCEPTING any portion lying within Bisbee Street and the right of way for U.S.R.R. C-1 Drain Canal.

\*\*Carolyn L. Zysk's interest - The execution of this deed by the Grantor (Carolyn L. Zysk) is being made at the direction of CLTC Exchange Company, as the herein described property is a portion of a tax deferred exchange by said Grantor.

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 57,500.00 \*\*. However, the actual consideration consists of or includes other property or value given or promised which is the whole/ part of the consideration (indicate which). In construing this deed and where the context so requires, the singular includes the plural and all grammatical changes shall be implied to make the provisions hereof apply equally to corporations and to individuals.
