OREGON shores, Block 9 Lot 2

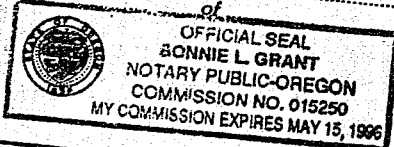
