## WARRANTY DEED

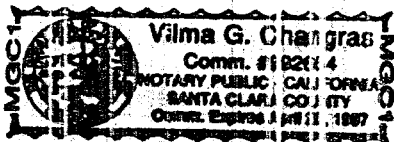
