DEED OF RECONVEYANCE

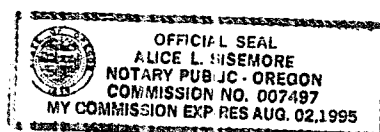

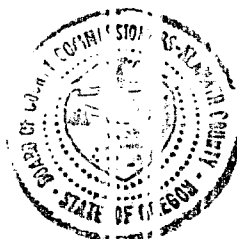
