CONSENT AGREEMENT

WHEREAS the United States of America, hereinafter called the Government, has an interest in the real property hereinafter described by virtue of a right-of-way easement deed dated May 23, 1962, and recorded May 16, 1963, in Volume **344**, Page **118**, in the records of Klamath County, Oregon, and which easement traverses the following described real property in the County of Klamath, State of Oregon to wit:

WHEREAS, Telephone Utilities of Eastern Oregon, Inc. dba PTI Communications, hereinafter called the Corporation, has need to construct, operate, maintain, and remove buried communications cable and the necessary buried and above ground appurtenances thereto within the Government's easement.

NOW THEREFORE, the Government consents to the construction, operation, maintenance, and removal of said cable and appurtenances within the Government's easement, subject to the following conditions:

Construction will be in accordance with construction drawings submitted to and on file with the Government in Klamath Falls, Oregon.

The Corporation shall repair all damage to National Forest roads caused by the Corporation in the construction, operation, maintenance, and removal of said cable and appurtenances.

3. This agreement is executed with the express understanding that should future location of Government's road require the relocation of the Corporation's cable and appurtenances, such relocation will be done by the Corporation at its expense within sixty (60) days following a written request to relocate.

4. The Corporation shall indemnify and hold harmless the Government against all claims or liabilities for damage to life or property arising from the Corporation's acts or ommissions in the construction, operation, and maintenance of said telephone cable and appurtenances.

5. This Consent Agreement is issued on the condition that the Corporation has secured, or will secure, the consent of any person having claim to the land.

NOW THEREFORE, the Corporation, by joining in the execution of this document, agrees to the conditions set forth above.
