TINA K. EMERY, hereinafter Grantor, conveys to PAUL G. NEIFFER, Trustee of the Tina K. Emery Trust Under Date 1/31/94, his heirs, successors and assigns hereinafter Grantee, a nonexclusive easement to use all existing roads on, over and across the following described real property as shown on the map attached hereto as Exhibit "A", and by this reference incorporated herein:

Township 30 South, Range 9 East of the Willamette Meridian
Section 5: SW1/4NW1/4, NW1/4SW1/4

Section 6: S1/2NE1/4SE1/4 N1/2SE1/4SE1/4

The terms of this easement are as follows:

1. Grantee, his agents, independent contractors and invitees shall use the roads for the purpose of removing timber from the adjacent real property; provided, however, that Grantee's use of the roads shall be subject to all of the terms and conditions of that certain Correction Bargain and Sale Timber Deed re-recorded 9/13/94, in Book M94, Page 28847, Official Records, Klamath County, Oregon.
2. Grantor reserves the right to use, construct, reconstruct and maintain the roads located upon the easement. The parties shall cooperate so that each party's use shall cause a minimum of interference to the others.
3. Grantee agrees to indemnify and defend Grantor from any loss, claim or liability to Grantor arising in any manner out of Grantee's use of the easement. Grantee shall pay Grantor for any property of Grantor damaged by Grantee's use of this easement. Grantee assumes all risk arising out of its use of the easement and Grantor shall have no liability to Grantee or others for any condition existing thereon. Grantee agrees and represents that Grantee is accepting the easement on the premises "AS IS".
4. This easement is appurtenant to the real property described below.
5. This easement shall terminate on the sooner of (a) August 31, 2024, or (2) the date on which Grantee has complete removal of the timber (Timber) granted under that Correction Bargain and Sale Timber Deed dated June 20, 1994, and re-recorded 9/13/94, in Book

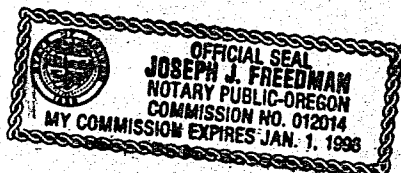

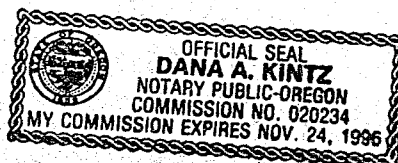
