## EXHIBIT "A" LEGAL DESCRIPTION

## PARCEL 1

A parcel of land situated in Lct 33, Section 16, Township 35 South, Range 7 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:

Beginning at the quarter section corner of the South boundary of Section 16. Township 35 Scuth, Range 7 East of the Willamette Meridian, Klamath County, Oregon; thence North along the center section line of Section 16, a distance of 13.0.0 feet to the Northwest corner of Lot 33, which corner is marked with a 3/4 inch iron pipe; then.
