
Assignment of Trust Deed by Beneficiary or Beneficiary's Successor In Interest

In Witness Whereof, Assignor has caused its name to be signed on August 17, 1994 effective as of October 15, 1994.

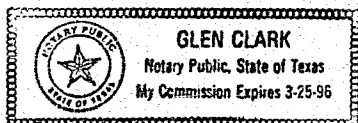
