


Assignment of Trust Deed by Beneficiary or Beneficiary's Successor In Interest

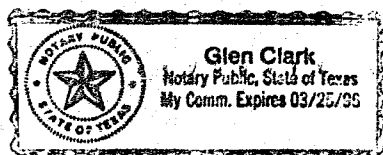


