THIS RELEASE is made as of the 12 day of October, 1994

W I T N E S S E T H:

1. The Strampes are the beneficiaries of the terms of a certain Well Agreement recorded on July 23, 1993 in Volume M 93 at Page 18080 of the Records of the Clerk of Klamath County, Oregon.

In paragraph 1. of said Well Agreement, the servient estate includes the following real property which is denoted as the "Cordonniers' land": S $\frac{1}{2}$ NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 17, and the S $\frac{1}{2}$ NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 16, Township 39 S., Range 8 E.W.M. in Klamath County, Oregon.

3. The description set forth on said Well Agreement and in paragraph 2. above is overbroad and included by error the S $\frac{1}{2}$ NE $\frac{1}{4}$ NE $\frac{1}{4}$ of said Section 17.

4. Bruce M. Strampe and Susan R. Strampe, husband and wife, do hereby quitclaim and release all rights which they may have under the above-referenced Well Agreement to the S $\frac{1}{2}$ NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 17, Township 39 S., Range 8 E.W.M. in Klamath County, Oregon.

5. This Release shall not affect or impair the right of Strampes under the terms of said Well Agreement with respect to the S $\frac{1}{2}$ NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 16, Township 39 S., Range 8 E.W. M. in Klamath County, Oregon.

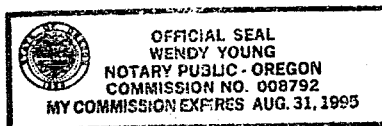
