\$ 4,700.00, Trustor/Grantor agrees that said Deed of Trust is hereby  
amended to secure payment of \$ 72,000.00 according to the terms of a  
modified or amended note or notes dated July 15, 1994 and  
maturing December 1, 2023 payable to Beneficiary.

Trustor/Grantor further understands and agrees that this amendment does not in any  
way affect the terms, conditions or priority of said Deed of Trust except as herein  
specifically set forth.

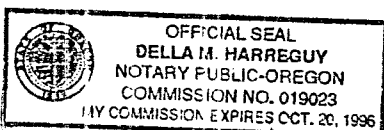
