In Witness Whereof, Assignor has caused its name to be signed on September 22, 1994 effective as of October 1, 1994.

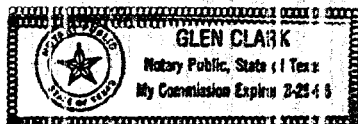
