WHEREAS, such expansion is adjacent to the existing area, conforms with the Plan's goals and guidelines and does not violate the Plan's basic planning principles; NOW

THE CITY OF KLAMATH FALLS RESOLVES AS FOLLOWS:

The boundary of the Amended Urban Redevelopment Plan and Report are amended to include the following described property:

Lots 15-17, Block 3 and Lots 9-15, Block 4, Canal Addition.

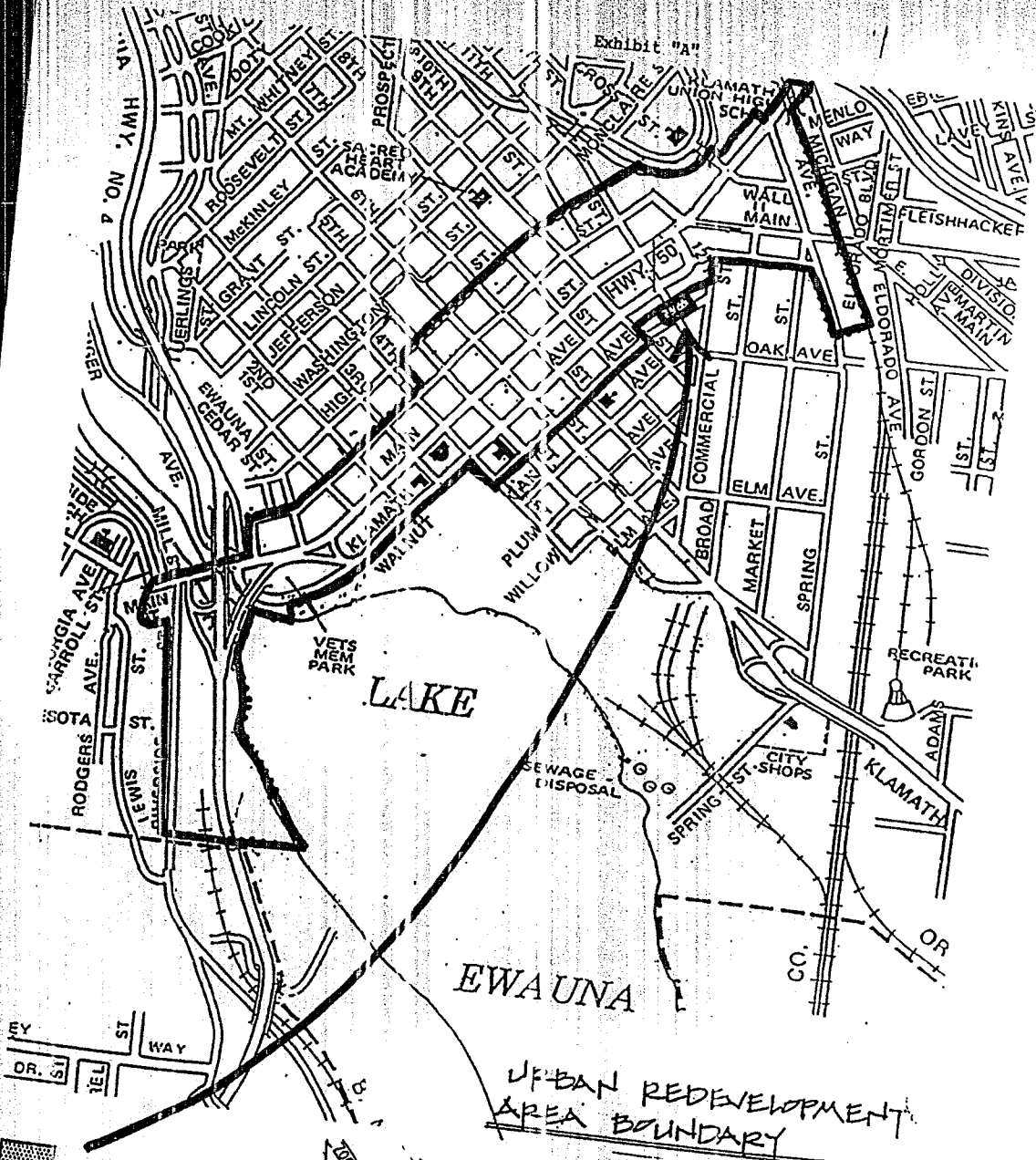

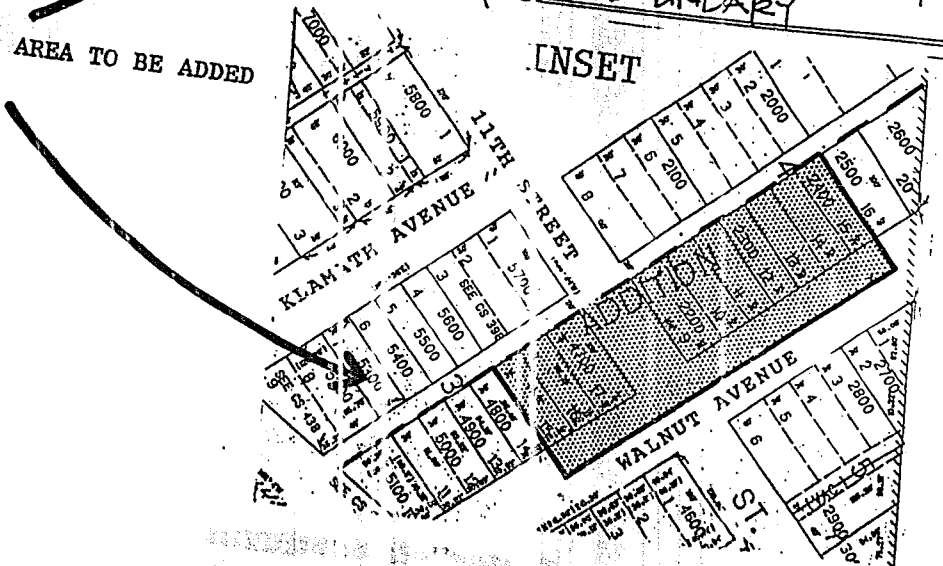
