GENERAL POWER OF ATTORNEY

And also for me and in my name, and as my act and deed to sign, seal, execute deliver and acknowledge such deeds, leases, mortgages, hypothecations, charter parties, bills of lading, bills, bonds, notes, receipts, evidence of a debt, releases and satisfaction of mortgage, judgments and other debts, and such other instruments in writing of whatsoever kind and nature as may be necessary or proper in the premises.

GIVING AND GRANTING unto my said attorney in fact full power and authority to do and perform every act necessary, requisite, or proper to be done in and about the premises as I might or could do if personally present, with full power of substitution and revocation, hereby ratifying and confirming all that my said attorney should lawfully do or cause to do by virtue hereof. This Power of Attorney is limited to one year.
