KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated December 28, 1992, executed and delivered by Vincent A. Foran and Robbin L. 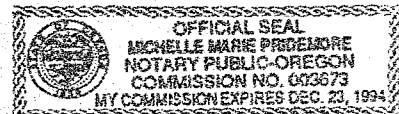
