TELEPHONE LINE RIGHT-OF-WAY EASEMENT

THE STATE OF OREGON, ACTING BY AND THROUGH THE DIRECTOR OF VETERANS' AFFAIRS, hereby grants to TELEPHONE UTILITIES OF EASTERN OREGON, INC., dba PTI Communications, its successors and assigns, (hereinafter referred to as the Company), the right to bury and maintain underground telephone facilities, together with all necessary wires and fixtures incidental thereto, under and upon the following described property situated in Klamath County, Oregon, to wit:

A parcel of land situated in the NE¹/₂ Section 4, T.36S., R.7E., W.M. Said parcel is more particularly described in that Contract of Sale recorded December 7, 1988 in Book M88 of Deeds at Page 20836 of Klamath County Records, said facilities to be located along the route generally flagged and agreed upon by the parties hereto on October 3, 1994.

provided however that, following completion of initial construction of the facilities authorized by this grant of easement, said easement shall become limited to a strip of land eight (8) feet in width, the centerline of said strip being contiguous to the centerline traverse of the buried telephone cables first placed hereunder.

It is agreed that the Company, its successors and assigns, shall have access to said premises for the purposes stated, and shall be responsible for any damage to said premises by reason of any negligence on the part of said Company's employees while placing and maintaining construction. Said property shall be restored, as nearly as reasonably possible, to prior condition in a workmanlike manner.
