And said Grantor hereby covenants to and with said Grantee and Grantee's successors, heirs and assigns, that Grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances and that Grantor will and Grantor's successors shall warrant and defend the above granted premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever.
