breakdown of the marriage, and the marriage should be dissolved and other relief granted. Now, therefore,

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED:

1. The parties' marriage is dissolved effective at midnight on November 24, 1994.

2. The personal property of the parties has already been divided and the personal property in each party's respective possession shall be awarded to that party.

3. Petitioner is awarded the real property described as follows:
