AGREEMENT REGARDING FILLING IN OF DRAINAGE DITCH

THIS AGRIENTENT, effective the 1st day of May, 1994, is made by and between the KLAMATH DRAINAGE DISTRICT, a drainage district formed pursuant to the laws of the State of Oregon, herein referred to as District, and LEE R. SUKRAW, herein referred to as Sukraw.

RECITALS:

1. WHEREAS, Sukraw has filled in a drainage ditch which belongs to the District, and Sukraw owns real property surrounding such drainage ditch, the location of such drainage ditch is described as follows:

That portion of a lateral or drain within the bounds of the Klamath Drainage District located along the I ast-West centerline of Section 29, T. 40 S., R. 9 E., Willamette Meridian and lying between the center of said section and the Westerly boundary hereof.

2. WHEREAS, The parties wish to define of record the relative rights and obligations of the parties and make them a matter of public record as herein set forth.

NOW THEREFORE, in consideration of the mutual covenants between the parties and in consideration of the District consenting to the filling in of such drainage ditch, the parties hereby agree and grant as follows:

- A. Sukraw hereby grants, agrees and covenants that the District shall not be responsible for future mainterance, operation or other obligations regarding such drain.
- B. Sukraw grants, agrees and covenants that in the event that Sukraw, his successors, lessees, assigns or personal representatives should request the district to reconstruct or maintain such drain or in the event that a claim or suit is brought against the District by Sukraw or such successors, the District shall not be under any obligations to construct, maintain, operate or any other liability arising from such drainage ditch having been filled in.
- C. The agreement and grants herein are not personal to the parties hereto, but shall run with the land and shall bind the successors and assigns hereto.
