10 Respondent and one-half to Respondent, in trust, for the benefit
11 of CHRISTIE L. BROOKS aka CHRISTIE L. PELICAN, and MARCIE B.
12 BROOKS aka MARCIE B. PELICAN.

13 C. The 1985 Toyota should be awarded to Respondent.

14 D. The 1972 Chevrolet should be awarded to Respondent.

15 E. All of the furniture and personal property of this
16 marriage should be awarded to Respondent, except the personal
17 property of Petitioner, such as clothing, photographs, jewelry,
18 personal furniture from her family, such as her personal dresser
19 and chair, and all of Petitioner's separate property which she
20 has inherited from her parents.

21 F. Respondent should be responsible for all of the debts
22 of the marriage.

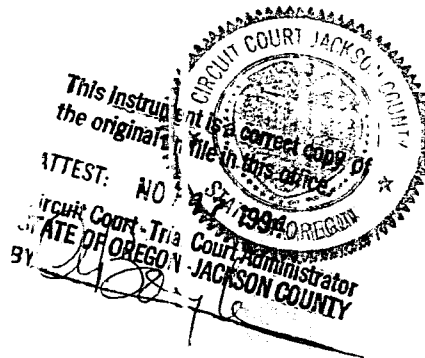
