1. CONVEYANCE AND GRANT.

Grantor presently assigns to Lender (also known as Beneficiary in this Line of Credit Trust Deed) all of Grantor's right, title, and interest in any improvements and to the Rents from the Property. In addition, Grantor grants Lender a Uniform Commercial Code security Interest in the Rents and the Personal Property defined below.

DEFINITIONS

The following words shall have the following meanings when used in the Line of Credit Trust Deed:

- a. Agreement. The word "Agreement" means the Equiline Credit Account Agreement dated December 5, 1994 the maximum principal amount at any one time of \$ 14,200.00
- b. Beneficiary. The word "Beneficiary" means Highland Community Federal Credit Union (Credit Union), its successors or easigns, elso referred to as "Lender" in
- c. Line of Credit Trust Deed. The words "Line of Credit Trust Deed" mean this Line of Credit Trust Deed among Grantor, Lender, and Trustee, and include without finitation all assignment and security interest provisions relating to the Personal Property and Rents.
- d. Grantor. The wor∴ "Grantor" means any and all persons and entities executing this Line of Credit Trust Deed.
- e. Improvements. The word "Improvements" means and includes without limitation all existing and future improvements, fixtures, buildings, sauctures, mobile homes
- Indebtedness. The word "Indebtedness" means all principal and interest payable under the Agreement and any amounts advanced or expended by Lender to discharge obligations of Grantor or expended by Trustee or Lender to enforce obligations of Grantor under this Line of Credit Trust Deed, together with interest on such amounts as provided in this Line of Credit Trust Deed. This Line of Credit Trust Deed secures a line of credit. The term "Line of Credit" means a revolving line of credit which obligates Lender to make advances to Grantor. In the maximum principal amount at any one time as set forth above until the Agreement is terminated or suspended or if advances are made up to the maximum credit limit, and Grantor compiles with the terms of the Agreement. Funds may be advanced by Credit Union, repaid by Grantor, and subsequently readvanced by Credit Union in accordance with the Agreement. Notwithstanding the amount outstanding at any particular time, this Line of Credit Trust Deed secures the total indebtedness under the Agreement. The unpaid belance of the line of credit under the Agreement will remain in full force and effect notwithstanding a zero outstanding belance on the line from time to time. Any principal advance under the line of credit that exceeds the amount outstanding at amount of the Agreement will not be secured by this Line of Credit Trust Deed. The term of the Agreement is thirty (30) years.
- g. Lender. The word "Lender" means Highland Community Federal Credit Union, its successors or assigns.
- Personal Property. The words "Personal Property" mean all equipment, lixtures, and other articles of personal property owned by Granter, now or hereafter attached or affixed to the Real Property; together with all accessions, parts, and additions to, all replacements of, and all substitutions for, any of such property; and together with all proceeds (including without limitation all insurance proceeds and refunds of premiums) from any sale or other disposition of the Property.
- 1. Property. The word "Property" means collectively the Real Property and the Personal Property.
- j. Real Property. The words "Real Property" mean the property, interests and rights described above in the "Conveyance and Grant" section.
- k. Related Documents. The words "Related Documents" mean and include without limitation all advance vouchers, loan agreements, quaranties, security agreements, mortgages, deeds of trust, and all other documents, whether now or hereafter existing, executed in connection with Grantor's indebtedness to Lender.
- 1. Rents. The word "Rents" means all rents, revenues, income, issues, and profits from the Property financed under an Equity Loan only.

This line of Credit Trust Deed, including the assignment of rents and the security interest in the rents and personal property, is given to secure (1) payment of the indebtedness and (2) performance of any and all obligations of grantor under the agreement and this line of credit trust deed. This line of credit trust deed is given and accepted on the following terms:

9. PAY:JENT AND PERFORMANCE

Granter shall pay to Lender all amounts secured by this Line of Credit Trust Deed as they become due, and shall strictly perform at of Granter's obligations under the Agreement and Line of Credit Trust Deed.

4. POSSESSION AND MAINTENANCE OF THE PROPERTY.

Grantor agrees that its possession and use of the Property shall be governed by the following provisions:

8. Possession and Use. Unless and until Lender takes any action under paragraph 17, Granter may (a) remain in possession and control of the Property, and (b) operate and manage the Property. The following provisions relate to the use of the Property or to other Emitations on the Property.

THIS INSTRUMENT WILL NOT ALLOW USE OF THE PROPERTY DESCRIBED IN THIS INSTRUMENT IN VIOLATION OF APPLICABLE LAND USE LAWS AND REQULATIONS. - b. Duty to Maintain. Granter shall maintain the Property in tenantable condition and promptly perform all repairs and maintenance necessary to preserve its value.
- c. Hazardous Substances. Grantor represents and warrants that the Property never will be so long as this Line of Credit Trust Deed remains a lien on the Property, used for the generation, manufacture, storage, treatment, disposal, release or threatened release of any hazardous substance, as those terms are defined in the Comprehensive Environmental Response, Compensation and Liability Act of 1990, as amended, 42 U.S.C. Section 9601, at seq. ("CEHCLA"), the Superfund Amendments and Reauthorization Act ("SARA"), applicable state laws, or regulations adopted pursuant to any of the foregoing. Grantor authorizes Lender and its agents to enter upon the Real Property to make such inspections and tests as Lender may deem appropriate to determine compliance of the Property with this paragraph. Any inspections or tests made by Lender shall be for Lender's purposes only and shall not be construed to create any responsibility or liability on the part of Lender to Grantor at to any other person. Grantor agrees to indemnify and hold Lender harmless against any and all claims and loases resulting from a breach of this paragraph of the Line of Credit Trust Deed.
- d. Nulsance, Waste. Grantor shall not cause, conduct or permit any nulsance nor commit or suffer any strip or waste on or to the Property or any portion thereof. Specifically without limitation, Grantor will not remove, or grant to any other party the right to remove, any timber, minerals (including oil and gas), soil, gravel or rock products without the prior written consent of Lender.
- e. Lender's Right to Enter. Lender and its agents and representatives may enter upon the Real Property at all reasonable times to attend to Lender's interest and to inspect the Property for purposes of Grantor's compliance with the terms and conditions of this Line of Credit Trust Deed.
- 1. Compliance with Governmental Requirements. Grantor shall promptly compty with all laws, ordinances, and regulations of all governmental authorities applicable to the use or occupancy of the Property. Grantor may contest in good faith any such law, ordinance, or regulation and withhold compliance during any proceeding, including appropriate appeals, so long as Grantor has notified Lender in writing prior to doing so and so long as Lender's interests in the Property are not jeopardized. Lender may require Grantor to post adequate security reasonably satisfactory to Lender, to protect Lender's interest.
- g. Duty to Protect. In addition to the acts set forth above in this section, Grantor shall do all other acts that from the character and use of the Property are resembly necessary to protect and preserve the Property.

A. INDEMNITY

Grantor shall indemnify Lender and hold Lender harmless from any and all claims or itabilities arising out of or in connection with the Property or its use, provided that such claims or liabilities arise out of acts or omissions occurring subsequent to the date Grantor first hods title to the property.

A DUF ON SALE - CONSENT BY LENDER.

Grantor shall not sell, or transfer its interest in the Real Property or any interest or part thereof, without the Lender's prior written consent. A sale, assignment, or transfer means the conveyance of real property or any right, title or interest therein; whether legal or equitable; whether voluntary or involuntary; whether by outright sale, deed, installment sale contract, land contract, contract for doed, lease-option contract, or by sale, assignment, or transfer of any beneficial interest in or to any tand trust holding title to the Real Property, or by any other method of conveyance of real property interest. Transfer also includes any change in contracting of more than fifty percent (50%) of the interests of Grantor. However, this option shall not be exercised by Lender II exercise is prohibited by federal law or by Oregon law.

7. LEASES - CONSENT REQUIRED.

For Equity Loans secured by this Line of Credit Trust Deed, Grantor may lease or sublet the Property. However, Grantor shall not lease or sublet the Property without Lender's prior written consent which shall not be withheld unreasonably. Lender shall have not more that ten (10) days to reject any such transaction proposed by Grantor, and the transfer shall be deemed approved unless rejected within such ten (10) day period. For lines of credit secured by this Line of Credit Trust Deed, Grantor may not lease or sublet the Property. Grantor represents and agrees that the Property will remain owner-occupied.

8. TAXES AND LIENS.

The following provisions relating to the taxes and liens on the Property are a part of this Line of Credit Trust Deed.

- a. Payment. Grantor shall pay when due before they become delinquent all taxes, special taxes, assessments, charges (including water and sewer), fines and impositions levied against or on account of the Property, and shall pay when due all claims for work done on or for services rendered or material furnished to the Property. Grantor shall maintain the Property free of all liens having priority over or equal to the interest of Lender under this Line of Credit Trust Deed, except for the lien of taxes and assessments current but not yet due, except as otherwise provided in this Line of Credit Trust Deed. If Grantor objects in good faith to the validity or amount of any tax, assessment, or related lien, Grantor at its sole expense may contest the validity and amount of the tax, assessment, or fien.
- b. Evidence of Payment. Granter shall upon demand furnish to Lender evidence of payment of the taxes or assessments and shall authorize the appropriate governmental official to deliver to Lender at any time a written statement of the taxes and assessments against the Property.

9. PROPERTY DAMAGE INSURANCE.

The following provisions relating to insuring the Property are a part of this Line of Credit Trust Deed.

- a. Maintenance of insurance. Granter shall procure and maintain policies of fire insurance with standard extended coverage endorsements on a replacement basis for the full insurable value covering all improvements on the Real Property in an amount not less than the total unpaid balance on the Agreement, and with a standard mortgagee dause in fevor of Lender. Policies shall be written in form, amounts, coverages and basis reasonably acceptable to Lender and issued by a company or companies reasonably acceptable to Lender. Granter, upon request of Lender, will deliver to Lender from time to time the policies or certificates of insurance in form setisfactory to Lender, including stipulations that coverages will not be cancelled or diminished without at least ten (10) days prior written notice to Lender.
- b. Application of Proceeds. In the event that the Improvements are damaged or destroyed by casualty, Grantor shall promptly restore the Improvements and Lender shall make the Insurance proceeds available to Grantor for restoration, subject to the following conditions: (a) Lender shall have reasonably determined that the Improvements can be restored to as good or better condition as the improvements were in Immediately prior to the casualty on account of which such proceeds were paid; (b) Lender shall have determined that such net proceeds, together with any funds paid by Grantor to Lender, shall be sufficient to complete the restoration; (c) No default and no event of failure which, with the passage of time or the giving of notice, would consider a default under this Line of Credit Trust Deed shall have occurred; (d) At the time of such casualty, there are at least two (2) years to the maturity date of the Note; (e) Lender shall have approved the plans and specifications to be used in connection with the restoration, which approval shall not be unreasonably withhold, and shall have received written evidence, satisfactory to Lender, that such plans and specifications have been approved by all governmental and quast-governmental authorities having jurisdiction and by all other persons or entities required to approve such plans and specifications; (f) Lender may require that the funds be disbursed by it or by a disbursement eigent appointed by it in a manner similar to that utilized for the disbursement of funds under a construction loan, including without limitation, requirement of cartificates of architect as to percentage of completion and the furnishing of appropriate bonds and other items as reasonably required by Lender. Net proceeds in excess of the amount necessary to complete the restoration shall, at the option of Lender, be applied to the outstanding indebtednass as a prepayment thereof.
- c. Unexpired insurance at Sale. Any unexpired insurance shall have to the benefit of, and pass to, the purchaser of the Property covered by this Line of Credit Trust Deed at any trustee's or other sale held under the provisions of this Line of Credit Trust Deed, or at any foreclosure sale of such Property.
- d. Grantor's Report on Insurance. Upon request of Lender, however not more than once a year, Grantor shall furnish to Lender a report on each existing policy of insurance showing: (a) the name of the insurer; (b) the risks insured; (c) the amount of the policy; (d) the property insured, the then current replacement value of such property, and the manner of determining that value; and (e) the expiration date of the policy.

10. EXPENDITURES BY LENDER.

If Granter tails to comply with any provision of this Line of Credit Trust Deed, or if any action or proceeding is commenced that would materially affect Lender's interest in the Property, Lender on Granter's behalf may, but shall not be required to pay all such expenses including but not limited to taxes, insurance and maintenence costs, and at Lender's option, will (a) be payable on demand, or (b) be added to the principal loan balance and be payable in accordance with the Agreement. This Line of Credit Trust Deed size of the principal continued by the provided for in this paragraph shall be in addition to any other rights or any remedies to which Lender may be entitled on account of the default. Any such action by Lender shall not be construed as curing the default so as to bar Lender from any remedy that it otherwise would have had.

The following provisions relating to ownership of the Property are a part of this Line of Credit Trust Deed.

- 9. Title. Grantor warrants that (e) Grantor holds good and marketable title of record to the Property in fee simple, free and clear of all tiens and encumbrances other tree. those sol forth in any policy of title insurance issued in favor of or in any title opinion given to, and accepted by, Lender in connection with this Line of Credit Trust Deed and (b) Grantor has the full right, power, and authority to execute and deliver this Line of Credit Trust Deed to Lender.
- b. Defense of Title. Subject to the exceptions in the paragraph above, if any, Grantor warrants and will forever defend the title to the Properly against the lawful deliment of all persons. In the event any action or proceeding is commenced that questions Grantor's title or the interest of Trustee or Lender under this Line of Credit Trust Deed, Grantor shall defend the action at its expense. Grantor may be the nominal party in such proceeding, but Lender shall be entitled to participate in the proceeding and to be represented in the proceeding by counsel of its own choice, and Grantor will deliver, or cause to be delivered, to Lender such instruments as may be requested by it from time to time to permit such participation.
- c. Compliance With Laws. Grantor warrants that its use of the Property complies with all existing applicable laws, ordinances, and regulations of governmental authorities.

12. CONDEMNATION.

The following provisions relating to proceedings in condemnation are a part of this Line of Credit Trust Deed.

- a. Application of Net Proceeds. If all or any part of the Property is condemned, Lender shall apply the net proceeds of the award in any reasonably manner necessary to satisfy Grantor's obligations under the Agreement of this Line of Credit Trust Deed. The net proceeds of the award shall mean the award after payment of all reasonable costs, expenses, and attorney less necessarily paid or incurred by Trustee or Lender in connection with the condemnation. However, there shall be no obligation to pay Grantor's costs, expenses or attorney fees from such awards.
- b. Proceedings. If any proceeding in condemnation is filed, Grantor shall promptly notify Lender in writing and Grantor shall promptly take such steps as may be necessary to defend the action and obtain the award. Grantor may be the nominal party in such proceeding, but Lender shall be entitled to participate in the proceeding and to be represented in the proceeding by counsel of its own choice, and Grantor will deliver or cause to be delivered, to Lender such instruments as may requested by it from time to time to permit such participation.

IMPOSITION OF TAXES BY GOVERNMENTAL AUTHORITIES.

The following provisions relating to taxes are a part of this Line of Credit Trust Doed.

- a. Taxes Covered. The following shall constitute taxes to which this section applies: (a) a specific tax upon this type of Line of Credit Trust Deed or upon all or any part of the indebtedness secured by this Line of Credit Trust Deed; (b) a specific tax on Borrower which Borrower is authorized or required to deduct from payments on the indebtedness secured by this type of Line of Credit Trust Deed chargeshie against the Lender; and (d) a specific tax on all or any portion of the indebtedness or on payments of principal and interest made by a Borrower.
- b. Remedies. If any tax to which this section applies is enacted subsequent to the date of this Line of Credit Trust Deed, Granter shall either (a) pay the tax before it becomes definquent, or (b) contest the tax as provided above in the Taxes and Liens section and deposits with Lender cash or a sufficient corporate surery bond or other security satisfactory to Lender.

14. SECURITY AGREEMENT; FINANCING STATEMENTS.

The following provisions relating to this Line of Credit Trust Deed as a security agreement are a part of this Line of Credit Trust Deed.

- a. Security Agreement. This instrument shall constitute a security agreement to the extent any of the Property constitutes fixtures or other personal property, and Lender shall have all of the rights of a secured party under the Uniform Commercial Code.
- b. Security Interest. Upon request by Lender, Grantor shall execute financing statements and take whatever other action is requested by Lender to perfect and continue Lender's security interest in the Rents and Personal Property. 16. FURTHER ASSURANCES; ATTORNEY-IN-FACT.

The following provisions relating to further assurances are a part of this Line of Credit Trust Deed.

- a. Further Assurances. At any time, and from time to time, upon request of Lender, Grantor will make, execute and deliver, or will cause to be made, executed or Further Assurances. At any time, and from time to time, upon request of Lender, Grantor will make, execute and deliver, or will cause to be made, executed or delivered, to Lender or to Lender's designee, and when requested by Lender, cause to be filed, recorded, re-filed, or re-recorded, as the case may be, at such times and in such offices and places as Lender may deem appropriate, any and all such mortagages, deeds of this, security deeds, security egreements, financing and in such mortagages, deeds of this, security egreements, financing attements, continuation statements, instruments of brither assurance, certificates, and other documents as may, in the sole opinion of Lender, be necessary or desirable in order to effectuate, complete, perfect, continue, or preserve (a) the obligations of Grantor under the Agreement, this Line of Gradit Trust Deed, and the desirable in order to effectuate, complete, perfect, continue, or preserve (a) the obligations of Grantor under the Agreement, this Line of Gradit Trust Deed on the Property, whether now owned or herester acquired by the Line of Credit Trust Deed on the Property, whether now owned or herester acquired by Grantor. Unless prohibited by law or agreed to the contrary by Lender in writing, Grantor shall reimburse Lender for all costs and expenses incurred in connection with the matters referred to in this paragraph.
- b. Attorney-in-Fact. If Grantor falls to do any of the things referred to in the preceding paragraph, Londor may do so for and in the name of Grantor and at Grantor's expense. For such purposes, Grantor hereby irrevocable appoints Lender as Grantor's attorney-in-fact for the purpose of making, executing, delivering, tilling, recording, and doing all other things as may be necessary or desirable, in Londor's sole apinton, to accomplish the matters referred to in the preceding paragraph.

16. FULL PERFORMANCE.

If Grantor pays all the Indebtedness, including without limitation all future advances, when due and otherwise performs all the obligations imposed upon Grantor under this Line of Credit Trust Deed and the Agreement, Lender shall execute and deliver to Trustee a request for full reconveyance and shall execute and deliver to Grantor suitable statements of termination of any financing statement on lie evidencing Lender's security interest in the Rents and the Personal Property. Any reconveyance fee required by law shall be paid by Grantor, if permitted by applicable law.

- 17. POSSIBLE ACTIONS OF LENDER. The Lender may take the following actions with respect to your Agreement under the circumstances listed below:
 - a. Termination and Acceleration. Except as set forth in the Agreement the Lender may, without further notice terminate your Agreement and require Grantor to pay the entire outstanding balance invited ately, and charge Grantor certain fees it any of the following happen":
 - (1) Grantor engages in any fraud or material misrepresentation in connection with the Agreement. For example, if there are false statements or omissions on Grantor's application or financial statements;
 - (2) Grantor does not meet the repayment terms of the Agreement;
 - (3) Grantor's actions or inactions adversely affect the collateral or Lender's rights in the collateral. For example, # Grantor falls to: maintain insurance, pay taxes; transfer title to or sell the collateral, prevent the foreclosure of any Items, or waste of the collateral,
 - b. Suspension of Credit/Reduction of Credit Limit. Lender may refuse to make additional advances on the line of credit or reduce the gradit limit during any period in which the following exist or occur:
 - (1) Any of the circumstances listed in a., above;
 - (2) The value of Grantor's dwelling securing the indebtedness declines significantly below its appraised value for purposes of the Agreement;
 - (3) Lender reasonably believes that Grantor will not be able to meet the repayment requirements of the Agreement due to a material change in Grantura financial
 - (4) Grantor is in default under any material obligations of the Agreement and Line of Credit Trust Deed;

(5) The maximum annual percentage rate under the Agreement is reached;
(6) Any government action prevents Lender from imposing the annual percentage rate provided for or impairs Lander's security interest such that the value of the interest is less than 120 percent of the credit line.
(7) Lender has been notified by government agency that continued advances would constitute an unsafe and unsound practice.

c. Changes in Terms. The Agreement permits Lender to make certain changes to the terms of the Agreement at specified times or upon the occurrence of specified events.

18. NOTICE OF DEFAULT.

In the event of a default under Paragraph 17.b(4), Borrower shall have an opportunity to remedy any such default within thirty (30) days after notice from the holder hereof. Notice shall be deemed to have been given when deposited in the United States mall, posseps fully prepaid, pertitled or return receipt requested and addressed to Borrower at the address listed above or to such other address as may be designated by written notice from Borrower.

In the event the Agreement is terminated, Trustee or Lender, at its option, may, not earlier than thicky (33) days after Grantor has been given written notice of the termination, exercise any one or more of the following rights and remedies, in addition to any other rights or remedies provided by law.

- a. Foreclosure. With respect to all or any part of the Real Property, the Trustee shall have the right to foreclose by notice and sale, and Lender shall have the right to foreclose by judicial foreclosure, in either case in accordance with and to the full extent provided by applicable law.
- b. UCC Remedies. With respect to all or any part of the Personal Property, Lender shall have all the rights and remedies of a secured party under the Uniform
- c. Collect Rents. Lender shall have the right, without notice to Grantor, to take possession of and manage the Property and collect the Rents, including amounts past due and unpaid, and apply the net proceeds, over and above Lender's costs, against the indobtedness. In furtherance of this right, Lender may require any tenant or other user of the Property to make payments of rent or use fees directly to Lender, the Grantor in revocably designates Lender as Grantor's attorney in fact to endorse instruments received in payment thereof in the name of Grantor and to negotiate the same and collect the proceeds. Payments by tenants or other users to Lender in response to Lender's demand shall satisfy the obligations for which the payments are made, whether or not any proper grounds for the demand existed. Lender may exercise its rights under this subparagraph either in person, by agent, or through a receiver.
- d. Appoint Receiver. Lender shall have the right to have a receiver appointed to take possession of any or all of the Property, with the power to protect and preserve the Property to operate the Property preceding foredocure or sale, and to collect the income from the Property and apply the proceeds, over and above cost of the receivership, against the indebtedness. The receiver may serve without bond if permitted by law. Lender's right to the appointment of a receiver shall exist whether or not the apparent value of the Property exceeds the indebtedness by a substantial amount. - e. Tenancy at Sufferance. - g. Notice of Sale. Lender shall give Grantor reasonable notice of the time and place of any public sale of the Personal Property or of the time after which any private sale or other intended disposition of the Personal Property is to be made. Reasonable notice shall mean notice given at least ten (10) day before the time of the sale or disposition. Any sale of Personal Property may be made in conjunction with any sale of the Real Property.
- h. Sale of the Property. To the extent permitted by applicable law, Grantor hereby waives any and all rights to have the Property marshalled. In exercising its rights and remedies, the Trustee or Lender shall be free to sell all or any part of the Property together or separately, in one sale or by separate sales. Lender shall be entitled to bid at any public sale on all or any portion of the Property.

20. WAIVER; ELECTION OF REMEDIES

A waiver by any party of a breach of a provision of this Line of Credit Trust Deed shall not constitute a waiver of or projudice the party's rights otherwise to demand strict compliance with that provision or any other provision. Election by Lender to pursue any remedy provided in this Line of Credit Trust Deed, the Agreement, in any Festated Document, or provided by law shall not exclude pursuit of any other remedy, and an election to make expenditures or to take action to perform an obligation of Grantor under this Line of Credit Trust Deed after failure of Grantor to perform shall not affect Lender's right to declare a default and to exercise any of its remedies.
