WARRANT DEED

CROWN PACIFIC LIMITED PARTNERSHIP, a Delaware limited partnership, Grantor, conveys and warrants to SVE II, INC., an Oregon corporation, Grantee, the real property in Deschutes and Klamath Counties, State of Oregon, legally described on the attached Exhibit A (the "Real Property"), free of encumbrances except as specifically set forth below and on the attached Exhibit B.

Grantor excepts from this conveyance and reserves unto Grantor and its successors and assigns all standing trees (both merchantable and pre-merchantable) and all down trees, in each case whether now in existence or hereafter growing, upon the Real Property. The reservation pursuant to this paragraph shall expire on the earlier to occur of (i) the date on which the holder of this reservation ("Holder") has completed the harvest of 204 million board feet of merchantable timber from the Real Property, or (ii) 15 years after the date of this Deed; provided, however, that such 15 year period shall be extended by the number of days, if any, that harvesting of timber from the Real Property is prevented by acts of God, insurrection, riot, labor disputes, governmental order, or other causes, similar or dissimilar, beyond the reasonable control of Holder; and provided further, that Holder shall promptly notify Grantee upon occurrence of the date described in clause (i) of this sentence. Upon expiration of this reservation, all rights with respect to trees then located on the Real Property shall automatically revert to Grantee or its successors or assigns. Holder shall execute, acknowledge, and deliver to Grantee or such successor or assign such instrument as may reasonably be requested to confirm such expiration and reversion.

Holder shall, during the term of the foregoing reservation, have the right to cut and remove from the Real Property any of the reserved trees and, in connection with such activities, to go upon the Real Property, to construct, maintain, and repair roads thereon, and to store harvested timber on the Real Property prior to removal; provided that Holder of this reservation shall comply with applicable laws, rules, and regulations. Holder shall (a) indemnify and hold harmless Grantee and its successors and assigns from any and all claims, liabilities, damages, costs, and expenses (including, without limitation, reasonable attorneys' fees) resulting from the exercise of the rights reserved in the foregoing reservation; and (b) pay all costs related to the construction, maintenance, and repair of any access roads used for the harvest of timber hereunder by Holder, to the extent resulting from use by or on behalf of Holder, including maintenance and repair of access roads owned by Grantee and its successors and assigns.

The consideration for this conveyance is property or value other than money.

THIS INSTRUMENT WILL NOT ALLOW USE OF THE PROPERTY DESCRIBED IN THIS INSTRUMENT IN VIOLATION OF APPLICABLE LAND USE LAWS AND REGULATIONS. BEFORE SIGNING OR ACCEPTING THIS INSTRUMENT, THE PERSON ACQUIRING FEE TITLE TO THE PROPERTY SHOULD CHECK WITH THE APPROPRIATE CITY OR COUNTY PLANNING DEPARTMENT TO VERIFY APPROVED USES AND TO DETERMINE ANY LIMITS ON LAWSUITS AGAINST FARMING OR FOREST PRACTICES AS DEFINED IN ORS 30.930.

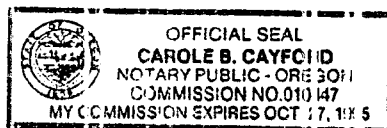
