DEED OF RECONVIVANCE

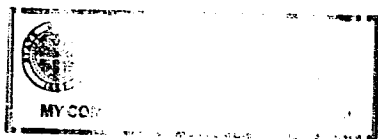

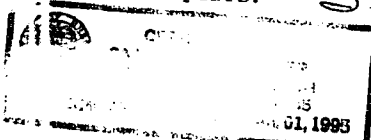

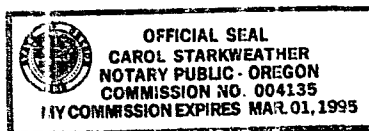
