THIS INDENTURE, Made this 9th day of January 9, 1995, between Scott D. MacArthur, hereinafter called trustes, and Capitol Industries, Inc., a nevada Corporation, hereinafter called the second party;

WITNESSETH:

RECITALS: Robin Fryling, as grantor, executed and delivered to Mountain Title Company of Klamath County, as trustee, for the benefit of Thomas B. Wasson, as beneficiary, a certain trust deed dated May 31, 1991, duly recorded on June 18, 1991, in the mortgage records of Klamath County, Oregon, in volume No. M91 at page 11614. In said trust deed the real property therein and hereinafter described was conveyed by said grantor to said trustee to secure, among other things, the performance of certain obligations of the grantor to the said beneficiary.
