BEGINNING AT A POINT ON THE SOUTH OF SAID TRACT 68, WHICH POINT IS WEST 105.25 FEET AND NORTH 0 DEGREES 11' EAST 30 FEET FROM THE CORNER COMMON TO SECTIONS 35 AND 36, TOWNSHIP 38 SOUTH, RANGE 9 EAST OF THE WILLAMETTE MERIDIAN AND SECTIONS 1 AND 2, TOWNSHIP 39 SOUTH, RANGE 9 EAST OF THE WILLAMETTE MERIDIAN; THENCE NORTH 0 DEGREES 11' EAST PARALLEL TO THE EAST LINE OF SAID SECTION 35, A DISTANCE OF 125 FEET, THENCE WEST 75 25 FEET; THENCE SOUTH 0 DEGREES 11' WEST 125 FEET, MORE OR LESS, TO THE SOUTH LINE OF SAID TRACT 68; THENCE EAST 105.25 FEET, MORE OR LESS TO THE POINT OF BEGINNING.

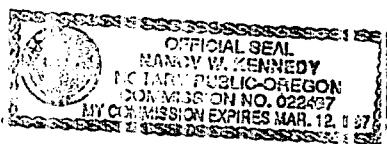

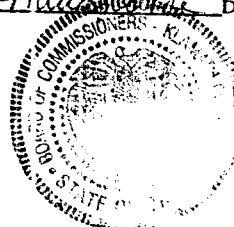
