That, I, Gregg Al Walder, hereby revoke, rescind and repudiate any and all implied or expressed powers of attorney or appointment as appears my signature on any and all applications, registrations, contracts of a unilateral or bilateral nature, under seal or otherwise of the Federal International municipal corporate State of Oregon and/or the United States of America, this day (nunc pro tune) August 20, 1953 and forever (ad infinitum), the same being made VOID ab initio, by operation of ORS 71.1030, 71.1050, as it pertains to ORS Chapter 128 et al. in the name of and benefit for "GREGG AL CRAMBLET," who was created wholly out of existence through the use of a Birth Certificate that was created by the exploitation of Fraud, Duress, Coercion, Mistake, and Bankruptcy under 12 USC § 95 and 50 USCS Appx 50 §§ 1 et seq., via material misrepresentations of fact and law;

That, I, Gregg Al Walder, sui juris, hereby repudiate the existence of my signature on any instrument expressed above by application of ORS 71.2020, 73.3070, and 73.4020 and Clyatt v. U.S., 197 U.S. 207 (1904); Jaremillo v. Romero, 1 N.Mex. 190, 194; and U.S. v. Kozminski, 487 US 931, 956 (1988) as it pertains to 42 USC \$\frac{8}{5}\$\$ 1991-1994 and 18 USC \$\frac{8}{5}\$\$ 1581-1584, the same being coerced upon me by fortiori and legally unenforceable in any in rem commercial tribunal of the State and/or Federal governments as well as its/there alter egos, third parties to the purpose and intent of this instrument by application of ORS 73.8030, entitling Gregg Al Walder to adequate assurance of due performance hereunder (ORS 72.6090) and complete Discharge thereunder (ORS 73.6010) by explicit reservation of rights without prejudice to Gregg Al Walder's choice of law forum to redress, recoupe and compensation for any violations, trespass, nuisance, tort or breach arising at any time during the operation of and purpose for the foregoing (see ORS 71.2070 et al.);

Page 1 of 2, NOTICE BY AFFIDAVIT/REVOCATION OF P.O.A. & APPOINTMENT:

That, I, Gregg Al Walder, sui juris, declare that it was never my knowing, intelligent, nor voluntary intent to participate in any venture for the benefits and privileges of limited liability and/or limited responsibility for the payment of debt, and that I am not now, nor have I ever knowingly, intelligently or voluntarily been a surety, pledgor, bailee nor obligor, subject to entrusting, to pay the debts of others nor be treated like chattel property without any Unalienable Rights secured to me by the Constitution of the United States of America and the Constitution of Oregon as Enemy Alien Capture Property in trust to the United States of America and/or any political subdivision thereunder, being a neutral party separate and apart therefrom, by reason of non-election to accept, claim, receive or be party to, nor officer of said trust, in any capacity thereunder, whatsoever, and particularly, as a citizen and/or resident agent of said trust, created by, or under operation and enforcement of the Fourteenth (14th) AMENDMENT to the Constitution of the United States of America; an unconsciounable juristic stigma;

CAVEAT ACTOR

TO ALL THOSE TO WHOM THESE PRESENTS SHALL COME, KNOW YE, THAT UPON THE ATTESTATION, NOTARIZATION, FILING AND RECORDING HEREOF, ANY TRESPASS, NUISANCE, TORT OR INTERFERENCE WITH THE STATED PURPOSE AND INTENT OF THE FOREGOING, SHALL BE TREATED AS A HOSTILE ATTEMPT TO OVERTHROW THE DE JURE SOVEREIGNTY OF AMERICA, THE FREEMEN AND INHABITANTS OF THE FIFTY (50) STATES PREELY ASSOCIATED AND PEACEFULLY ASSEMBLED, CONSTITUTE TREASON AGAINST THEM, AND BE DEALT WITH APPROPRIATELY TO THE FULLEST EXTENT THE LAW OF THIS LAND ALLOWS, AND THAT ANY SUCH ACTS MUST BE PRECEDED BY AN ANSWER HERETO WITHIN THIRTY (30) DAYS UPON NOTICE AND RECEIPT HEREOF, ON A POINT BY POINT BASIS, OR BE CONSIDERED AS A DISHONOR WITHOUT CAUSE HERETO PRIMA FACIE EVIDENCING OBSTRUCTION AND CONSPIRACY TO OBSTRUCT THE RIGHTS, REMEDIES AND RECOURSE OF NOTICOR UPON NOTICEE.
