

DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under those certain trust deeds dated October 22, 1976, executed and delivered by Randy L. Shaw and Carolyn J. Shaw, husband and wife, as grantor and recorded on October 26, 1976 in the Mortgage Records of Klamath County, Oregon, in book M76, at page 17000,; re-recorded to correct page number on recording date on January 27th, 1977 in Volume M77, on page 1554 and March 25, 1981, executed and delivered by Randy L. Shaw and Carolyn J. Shaw, husband and wife, as grantor and recorded on March 26, 1981, in the Mortgage Records of Klamath County, Oregon in book M81, at page 5443 conveying real property situated in said county described in above mentioned trust deeds, having received from the beneficiary under said trust deeds a written request to reconvey, reciting that the obligation secured by said trust deeds has been fully paid and performed, hereby does grant, bargain, sell and convey, but without any covenant or warranty, express or implied, to the person or persons legally entitled thereto, all of the estate held by the undersigned in and to said described premises by virtue of said trust deeds.

In construing this instrument and whenever the context hereof so requires, the masculine gender includes the feminine and neuter and the singular includes the plural.

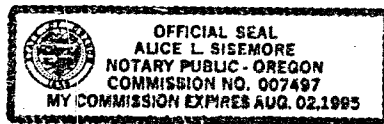
