

WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That JELD-WEN, Inc., an Oregon corporation successor by merger to TRENDWEST, Inc., an Oregon corporation successor by merger to **see continued hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by RODNEY L. BELL and MARCELLA M. BELL, husband and wife, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, the certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

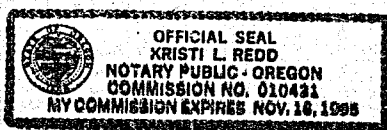
