WHEREAS, BIBLE BAPTIST CHURCH, AN OREGON NON PROPIT ORGANIZATION IS THE OWNER AND HOLDER OF THE NOTE SECURED BY A DEED OF TRUST RECORDED ON JULY 24, 1992, IN VOLUME M92, PAGE 15883, MICROFILM RECORDS OF KLAMATH COUNTY, OREGON, WHICH COVERS THE REAL PROPERTY DESCRIBED AS PER EXHIBIT "A" ATTACHED HERETO AND MADE A PART HEREOF, AND

WHEREAS, BIBLE BAPTIST CHURCH, AN OREGON NON PROFIT ORGANIZATION AND ROBERT W. THIBODEAU AND JULIANNE M. THIBODEAU, HUSBAND AND WIFE, NOW THEREFORE IN CONSIDERATION, PROMISES AND COVENANTS TO ASSUME SAID NOTE AND DEED OF TRUST HEREIN CONTAINED, THE PARTIES HERETO AGREE AS POLICIES:

- 1. THAT THE PRINCIPAL BALANCE OF THE NOTE AS OF THE EFFECTIVE DATE OF THIS MODIFICATION IS THE SUM OF: THIRTEEN THOUSAND, SIX HUNDRED THIRTEEN AND 33/100 (\$13,613.33), WITH INTEREST THEREON AT THE RATE OF (10%) TEN PERCENT PER ANNUM, FROM JANUARY 27, 1995.
