EXHIBIT A LEGAL DESCRIPTION

PARCEL 1

Beginning at a point on the South line of Maryland Street, 110 feet West of the West line of Altamort Irive in Trest 1 of Block 5, FIRST ADDITION TO ALTAMONT ACRES, according to the official plat thereof on file in the office of the County Clerk of Flacath County, Oregon; thence West along the South line of said Maryland Street, a distance of 90 feet to a point; thence South at right angles to said Maryland Street, a distance of 100 feet to a point; thence East at right angles to Altamort Drive and parallel with said Maryland Street, a distance of 90 feet; thence North parallel with the West line of Altamort Drive, a distance of 100 feet to the point of beginning.

PARCEL 2

The Westerly 10 feet of Lot 1, Block!, FIRST ADDITION TO ALTAMONT ACRES, according to the official plat there on file in the office of the County Clerk of Klamath County.
