EXHIBIT A LEGAL DESCRIPTION

PARCEL 1

Beginning at a point on the South line of Maryland Street, 110 feet West of the West line of Altamort Irive in Tract 1 of Block 5, FIRST ADDITION TO ALTAMONT ACRES, according to the official plat thereof on file in the office of the County Clerk of Placeth County, Oregon; thence West along the South line of said Maryland Street, a distance of 90 feet to a point; thence South at right angles to said Maryland Street, a distance of 100 feet to a point; thence East at right angles to Altamort Drive and parallel with said Maryland Street, a distance of 90 feet; thence North parallel with the West line of Altamort Drive, a distance of 100 feet to the point of beginning.
