DEED IN SATISFACTION OF MORTGAGE INDEBTEDNESS

WHEREAS, JAMES E. OTTOMAN AN) GAIL A. OTTOMAN hereinafter called the "Borrower," became indebted to the UNITED STATES OF AMERICA, acting through the Farmers Home Administration, United States Department of Agriculture, hereinafter called the "Government," by reason of loans made by the Government and to secure said indebtedness, the Borrower made, executed, and delivered to the Government that certain Real Estate Mortgage(s) as follows:

Dated February 14, 1980, filed February 14, 1980, in Book M80, Page 3047 of the Mortgage Records of Klamath County, State of Oregon;

Dated February 6, 1978, filed February 7, 1978, in Book M78, Page 2265 of the Mortgage Records of Klamath County, State of Oregon;

Dated June 12, 1973, filed June 29, 1973, in Book M73, Page 8326 of the Mortgage Records of Klamath County, State of Oregon;

WHEREAS, the Borrower has defaulted in the performance of the conditions of the Real Estate Mortgage(s) and the indebtedness secured thereby and the right of the Government to foreclose has accrued; and

WHEREAS, the Government desires to avoid the expense involved in a foreclosure of the Real Estate Mortgage(s) and the Borrower desires to avoid a deficiency judgment being taken against him and the Borrower desires to convey to the Government the title to the real property described in said Real Estate Mortgage and the Covernment desires to accept such a conveyance in full satisfaction of the indebtedness secured by said Real Estate Mortgages, the parties hereto being fully advised and acting freely and voluntarily;

NOW, THEREFORE, in consideration of the cancellation of the indebtedness and for other good and valuable consideration, the Borrower does hereby grant, bargain, sell and convey unto the United States of America, and assign all of the following described real property situated in the County of Klamath, State of Oregon, to wit:

PARCEL 1: That portion of SE 1/4 of NE 1/4 of Section 4, Township 41 South, Range 12, East of the Willamette Meridian, lying South of the High Line Irrigation Canal of Malin Irrigation District, LESS the portion thereof lying East of a line commencing 1:0 feet West of the Southeast corner of Said SE 1/4 of NE 1/4 and running North to said High Line Canal.

PARCEL 2: All of the portion of the E 1/2 of SE 1/4 of Section 4, Township 41 South, Range 12, East of the Willamette Meridian, lying Easterly and Northeasterly of the High Line Irrigation canal of Malin Irrigation District, EXCEPTING the following described property conveyed to D.D. and Dave Liskey by Deed recorded in Deed Book 120 at Page 553:
