EXCLUSIVE EASEMENT

JIM L. EVINS and JACKIE E. EVINS, husband and wife, as to an undivided ½ interest and JERRY DALE STACKHOUSE and ROBERTA J. STACKHOUSE, husband and wife, as to an undivided ½ interest, hereinafter called first party, in consideration of value paid by PACIFIC GAS TRANSMISSION COMPANY, a California corporation, hereinafter called second party, the adequacy and receipt whereof are hereby acknowledged, hereby grants to second party the exclusive right to use, occupy, and enclose with a fence, for the purposes of installing, maintaining and operating second party's aboveground appurtenances to its pipelines, a parcel of those certain lands more particularly described as follows:

A parcel of land situated in Section 31, Township 39 South, Range 8 East of the Willamette Meridian, in the County of Klamath, State of Oregon, more particularly discribed as follows:

Beginning at a point on the Southerly line of the Weyerhauser Timber Company Private Logging Road and the Southeasterly right of way line at the old county road know as "Puckett Road" from which the Northeast corner of Lot 17, Block 8, KLAMATH RIVER ACRES bears the following two bearings and distances North 63° 02' 00" West 50.38 feet, South 19° 53' 57" West 60.45 feet; thence from said point of beginning Southwesterly along the Easterly right of way line of the said old county road known as "Puckett Road" 606 feet, more or less, to the Westerly right of way line of the Klamath Falls-Ashland Highway (Highway 66); thence Northeasterly along the Westerly right of way line of said Klamath Falls-Ashland Highway (Highway 66) 608 feet, more or less to the Southerly line of the said Weyerhauser Timber Company Private logging Road; thence Westerly along the Southerly line of the said Weyerhauser Timber Company Private Logging Road 153 feet, more or less, to the point of beginning.

It is agreed between the parties that said parcel shall be thirty-five feet by fifty feet (35' x 50') as shown on the attached map, Exhibit "A."

Second party may further define the location of said parcel by recording a "Notice of Location" referring to this instrument and setting forth a legal description of the location of said parcel, which description may be set forth by map attached to said Notice. A copy of said Notice shall be delivered to first party.

First party grants to second party:

(a) the right of ingress to and egress from said parcel over and across said lands by means of roads and lanes thereon, if such there be, otherwise by such practicable route or routes as shall occasion the least damage and inconvenience to the first party;

(b) the right from time to time to trim and to cut down and to clear away any and all trees and brush now or hereafter on said parcel and to trim and cut down and to clear away any trees on any side of said parcel which now or hereafter in the opinion of second party may be a hazard to second party's facilities or may interfere with the exercise of second party's rights hereunder.

Second party hereby covenants and agrees:

(a) second party shall indemnify first party against any loss or damages which shall be caused by any wrongful or negligent act or omission of second party or of its agents or employees in the course of their employment.

First party agrees that second party has the exclusive use of said parcel and further agrees not to grant any easement or easements on, under, or over said parcel without the written consent of second party.

The provisions hereof shall inure to the benefit of and bind the heirs, successors, and assigns of the respective parties hereto, and all covenants shall apply to and run with the land.
