TERMINATION OF EASEMENT

THIS TERMINATION OF EASEMENT, dated this 6th day of February, 1995, by the UNITED STATES OF AMERICA, acting by and through the Forest Service, Department of Agriculture,

WHEREAS, Weyerhaeuser Company granted to the United States of America an easement for the South Camp Six Road No. 3506, 3506A, and 3506B dated October 7, 1980, and recorded on October 28, 1980, as Instrument No. 91828 in Book M 80, at page 20968, County of Klamath, State of Oregon, over and across the following described premises:

- T. 35 S., R. 14 E., W.M.
- sec. 4, NW1/4SW1/4
- sec. 5, NE1/4, NE1/4SW1/4, SW1/4SW1/4,
NE1/4SE1/4 and NW1/4SE1/4
- sec. 6, SW1/4SE1/4 and SE1/4SE1/4

which easement contained the following provisions:

"If for a period of five (5) years the Grantee shall cease to use, or preserve for prospective future use, the road, or any segment thereof, for the purposes granted, or if at any time the Regional Forester determines that the road, or any segment thereof, is no longer needed for the purpose granted, the easement traversed thereby shall terminate."

WHEREAS, the undersigned has determined that the United States of America has no further need for said easement.

NOW THEREFORE, this TERMINATION OF EASEMENT is executed for the purpose of showing that it has been determined that the United States of America has no further need for the easement and that the easement pursuant to its provisions has ceased and terminated and is hereby cancelled.

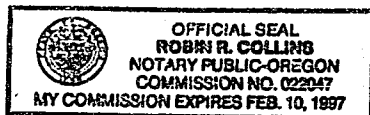
