TERMINATION OF A SEGMENT OF AN EASEMENT

THIS TERMINATION OF A SEGMENT OF AN EASEMENT dated this 21st day of February, 1995, by the United States of America, acting by and through the Forest Service, Department of Agriculture.

WHEREAS, WEYERHAEUSER COMPANY granted to the UNITED STATES OF AMERICA an easement dated, September 21, 1970, and recorded April 8, 1971, Vol. M 71, page 2951, Records of Klamath County, State of Oregon, which easement contained the following provisions:

"If for a period of five (5) years the Grantee shall cease to use, or preserve for prospective future use, the roads, or any segment thereof, for the purposes granted, or if at any time the Regional Forester determines that the roads, or any segment thereof is no longer needed for the purposes granted, the easement traversed thereby shall terminate."

WHEREAS, the undersigned has determined that the United States of America has no further need for a segment of said easement over and across the following lands as shown on Exhibit A attached hereto and made a part hereof in the County of Klamath, State of Oregon:

NOW THEREFORE, this TERMINATION OF A SEGMENT OF AN EASEMENT is executed for the purpose of showing that it has been determined that the United States of America has no need for that segment of easement and that the segment of easement pursuant to its provisions has ceased and terminated and is hereby cancelled as to that segment herein described.


