The applicant was represented by Doug Adkins of Adkins Consulting Engineers, who offered testimony.

FINDINGS OF FACT

The applicant requests a Conditional Use Permit to allow construction of a well house and 1,000,000 gallon water reservoir on approximately .64 acres. Included in the request is a request for permission to construct a six (6) foot high chainlink fence around the entire property perimeter. The well house is to be a masonry and woodframe structure. The use complies with policies of the Comprehensive Plan. The use is in conformace with all other required standards and criteria of the Code. The location, size, design, and operating characteristics of the proposed use will not have a significant adverse impact on the livability, value or appropriate development of abutting properties and the surrounding area, in light of the conditions imposed by the Order set forth hereinafter.

CONCLUSIONS OF LAW

Applicant's request for a Conditional Use Permit complies with the policies of the Comprehensive Plan, and is in conformance with all other required standards and criteria of the Code. Further, the location, size, design and operating characteristics of the proposed use will not have a significant adverse impact on the livability, value or appropriate development of the abutting properties and the surrounding area. The Conditional Use Permit should thus be granted, with the conditions as set forth hereinafter.

ORDER

IT IS HEREBY ORDERED that the requested Conditional Use Permit is granted, subject to the specific conditions set forth as follows:

1. The applicant will construct a six (6) foot high chainlink fence around the entire property perimeter, and maintain the same in good condition;

2. The facilities will be painted (or a similar coating applied) so as to blend with the environment;

3. The reservoir tank is to be recessed into the hill so as to minimize view obstruction, and landscaped so as to minimize view impact.
