WHEREAS, on the 16th day of March, 1995, Glenn C. Miller, conveyed to Klamath County, Oregon certain property for County Road, purposes, described as follows:

A parcel of land, situated in the NW1/4, NW1/4 of Section 1, Township 39 South, Range 9 East, Willamette Meridian, Klamath County, Oregon, for road purposes; being a portion of that property described in Deed Volume 264, Page 610 recorded in the Klamath County Clerk's Office, and being more particularly described as follows:

Commencing at the Initial Point of the "First Addition to Winema Gardens" thence South 45 degrees 04' 28" West a distance of 42.49 feet to the true point of beginning, which is a 5/8" iron pin set on the westerly right-of-way of Patterson Street and the southerly right-of-way of Shasta Way; thence South 00 degrees 10' 00" West along the westerly rightof-way of Patterson Street a distance of 20.00 feet to a 5/8" iron pin; thence North 44 degrees 55' 32" West a distance of 28.24 feet to a 5/8" iron pin; thence North 89 degrees 58' 55" East along the southerly right-of-way of Shasta Way a distance of 20.00 feet to the point of beginning. Said parcel contains 200 square feet.

Bearings and distances for this description are based on Survey #5679 on file at the Klamath County Surveyor's Office.

WHEREAS, the Board of County Commissioners of Klamath County, Oregon sitting in regular session deemed it to be in the best interest of said County to accept the herein described property for County Road purposes;
