- 17. POSSIBLE ACTIONS OF LENDER. The Lender may take the following actions with respect to your Agreement under the circumstances listed below:
 - a. Termination and Acceleration. Except as set forth in the Agreement the Lender may, without further notice terminate your Agreement and require Grantor to pay the ntire outstanding balance immediately, and charge Grantor certain tees if any of the following happen":
 - (1) Grantor engages in any fraud or meterial missegresentation in connection with the Agreement. For example, if there are false statements or omissions' on
 - Grantor's application or financial statementa;
 - (2) Granter does not meet the repayment forms of the Agreement;

- b. Suspension of Credit/Reduction of Credit Limit. Lender may refuse to make additional advances on the line of credit or reduce the credit limit during any period in which the following exist or occur:

(1) Any of the circumstances listed in a., above;

- (2) The value of Grantor's dwelling securing the indebtedness declines significantly below its appraised value for purposes of the Agreement;
 - (3) Lender reasonably believes that Gruntor will not be able to meet the repayment requirements of the Agreement due to a material change in Grantor's financial

 - (4) Grantor Is in default under any material obligations of the Agreement and Line of Credit Trust Deed;



- c. Changes in Terms. The Agreement permits Lender to make certain changes to the terms of the Agreement at specified times or upon the occurrence of specified events. est
 - In the event of a default under Paragraph 17.b(4), Borrower shall have an opportunity to remedy any such default within thirty (30) days after notice from the holder hereof. Notice shall be deemed to have been given when deposited in the United States mail, postage fully prepaid, cortilied or return receipt requested and addressed to Borrower at the address listed above or to such other address as may be designated by written notice from Borrower. 18. NOTICE OF DEFAULT.
