KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated May 30, 1978, executed and delivered by MICHAEL D. MOLLING & DEBBIE A. 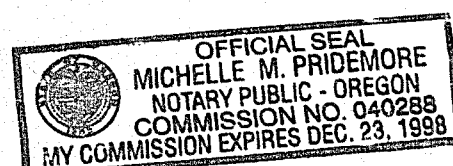
