KNOW ALL MEN BY THESE PRESENTS, That

hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

PARCEL 2: The N1/2 SW1/4 SW1/4 NW1/4, Section 20, Township 35 South, Range 13 East of the Willamette Meridian, in the County of Klamath, State of Oregon.

EXCEPT THEREFROM the Westerly 50 feet for ingress and egress.

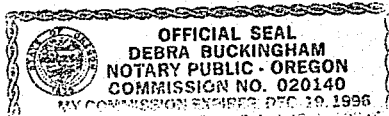
