

AMENDMENT TO AN EASEMENT

THIS AMENDMENT, made and entered into this 10th day of March, 1995, by and between **CAMERON A. CURTISS dba ROCK CREEK RANCH**, herein called "Rock Creek Ranch," and **WEYERHAEUSER COMPANY**, a Washington corporation, herein called "Weyerhaeuser," WITNESSETH:

I.

WHEREAS, by Easement dated January 31, 1995, Rock Creek Ranch granted an easement referred to herein as the "Original Easement," to Weyerhaeuser, said easement being recorded in the records of Klamath County, Oregon on February 8, 1995 in Volume M95, page 2809.

WHEREAS, it has been revealed that specific subdivisions listed under the description for certain road segments noted on Exhibit A of said Original Easement were meant to be excluded; and

WHEREAS, Rock Creek Ranch and Weyerhaeuser desire that the certain specific subdivisions should be deleted therefrom.

II.

NOW, THEREFORE, Rock Creek Ranch and Weyerhaeuser mutually agree that beginning on the date herein subscribed, the "Original Easement" is hereby amended as follows:

- A. The NE $\frac{1}{4}$ SE $\frac{1}{4}$ is hereby deleted from the subdivision listed as the E $\frac{1}{2}$ SE $\frac{1}{4}$ of Section 8, Township 37 South, Range 7 East, W.M.; and
- B. All of Section 9, Township 37 South, Range 7 East, W.M. is hereby deleted from said "Original Easement."

Except as herein expressly amended, the "Original Easement" shall remain in full force and effect.

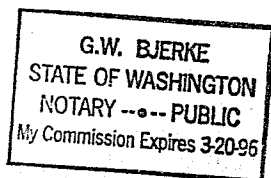

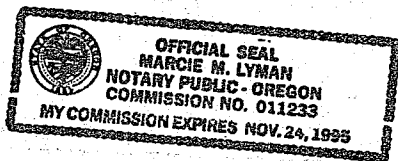
