KNOW ALL MEN BY THESE PRESENTS, that the undersigned trustee or successor trustee under that certain trust deed dated July 8, 19 93, executed and delivered by ROBERT L. ALLBEE & SANDRA J. 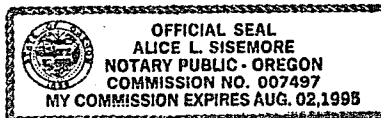
