Olson, Grantee, all of the timber standing upon that certain Property (the "Property") in Klamath County, Oregon as more fully described in Exhibit A attached hereto and made a part of this Timber Deed.

Consideration. The true and actual consideration for this transfer is to clear title to the timber. The Grantor makes no concerning warranties the timber as the Grantor contemporaneously conveyed the real property upon which the timber stands to the Grantee by warranty deed. The Grantee has contemporaneously executed a trust deed to the Grantor on a portion of the real property described in Exhibit A as security for the indebtedness of the Grantee to the Grantor. This Timber Deed is granted to allow the Grantee to sell or harvest all of the timber upon the above described real property free of any claim by the Grantor including the above mentioned Trust Deed.

Grantee shall be liable for and shall hold the Grantor harmless from any severance and forest products harvest taxes which result from the harvesting of the timber.

Statutory Language. This instrument will not allow use of the property described in this instrument in violation of applicable land-use laws and regulations. Before signing or accepting this instrument, the person acquiring fee title to the property should check with the appropriate City or County Planning Department to verify approved use.
