may at any time perform any act, exercise any power, execute any trust, and make any reconveyance thereunder.

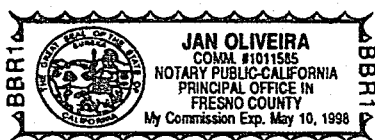
